- Awarded 55 projects with funding from a variety of programs including: ACAP, CEG, CAP, Exelon, ARPA.
- Planned more than 1,600 acres with an Ag E&S Plan.
- Designed 190 Best Management Practices and Installed over 100 BMPs.
- Reviewed 123 Act 38 Nutrient Management Plans.
- Developed 17 Manure Management Plans.
- Conducted status reviews of over 300 Act 38 regulated operations and/or CAFO's.
- Completed 147 Chesapeake Bay farm compliance visits.
- Distributed more than \$120,000 to farmers through the PACD Plan Reimbursement Program.



Watershed Program Project dollars totaling more than \$1.2 mill

- Installed 2 more Continuous Instream Monitoring units in priority watersheds for a total of 12 in the county.
- Nearly 1.5 miles of streams have been restored by the District's Watershed Program in 2023: Over 3,400 ft. of mudsills installed, 3 log/cross vanes and over 13.3 acres of riparian buffer planted (2,000 trees/shrubs planted).
- Assisted more than 10 local volunteer watershed associations with education, funding, monitoring, and volunteer recruitment.
